## Reminder: New Century Health Oncology Prior Authorization Effective November 1, 2022 (Medicaid and Marketplace)

A friendly reminder to the notification you received September 1, 2022, regarding oncology-related infused and injectable chemotherapeutic agents, supportive/symptom management medications and radiation treatments administered in a physician’s office, outpatient hospital or ambulatory setting will be submitted to New Century Health for prior authorization (PA) effective November 1, 2022. This requirement applies to all specialties for your Medicaid members 21 years of age and older, and Marketplace members 18 years of age and older.
