



Prior Authorization Change - Effective January 1, 2021 Substance Use Disorder (Marketplace)

Effective January 1, 2021, requirements for Prior Authorization (PA) with Molina Healthcare of Washington will change for the following CPT and HCPCS codes related to Substance Use Disorder. This change affects **Molina Marketplace members**. Molina will require a PA for both participating and non-participating providers for claims submitted for any place of service. Below is a list of codes that will require a PA.

Presumptive and Definitive Drug Screening

80320	Drug screen quantitative alcohols	PA REQUIRED after 24 cumulative tests completed
80324	Drug screen quantitative amphetamines 1 or 2	PA REQUIRED after 24 cumulative tests completed
80346	Drug screening Benzodiazepines 1-12	PA REQUIRED after 24 cumulative tests completed
80348	Drug screening Buprenorphine	PA REQUIRED after 24 cumulative tests completed

G0480	Drug identification methods able to identify individual drugs and distinguish between structural isomers (but not necessarily stereoisomers); method or drug-specific calibration and matrix-matched quality control material (e.g., to control for instrument variations and mass spectral drift); qualitative or quantitative, all sources, includes specimen validity testing, per day; 1-7 drug classes.	PA REQUIRED after first 16 cumulative tests are completed
G0481	Drug identification methods able to identify individual drugs and distinguish between structural isomers. 8-14 drug class(es), including metabolite(s) if performed.	PA REQUIRED after first 16 cumulative tests are completed
G0482	Drug identification methods able to identify individual drugs and distinguish between structural isomers. 15-21 drug class(es), including metabolite(s) if performed	PA REQUIRED after first 16 cumulative tests are completed

G0483	Serum comprehensive drug screen	PA REQUIRED after first 16 cumulative tests are completed
G0659	Drug Test Definitive Drug ID Meth Any # Dr. Classes	PA REQUIRED after first 16 cumulative tests are completed

Up to 16 cumulative definitive tests will be reimbursed per client, per year without a PA.
